

PRE-MBA/MBA PROGRAM







The PRE-MBA/MBA program is designed for international university students studying in business related majors who have completed 3 years of university courses and wish to pursue a Pre-MBA program leading to an accelerated MBA degree (as few as 12 months) through the **College of Business** at SF State.

PROGRAM OVERVIEW

The program focus is on helping create a stronger conceptual and practical foundation for students who wish to pursue an MBA degree on 3+1+1 model. All Pre-MBA students are required to take and pass the following eight courses to meet MBA foundation requirement:

- Applied Business Forecasting
- Business Communications for Professionals
- Historical and Contemporary Aspects of Food,
 Beverage and Culture in America
- International Marketing Management

- Introduction to International Business Negotiation
- Operations Management
- Seminar in Business Policy and Strategic Management
- Seminar on Business and Society

Students who pass all eight courses in the program and maintain a 3.0 or higher GPA, plus earn a bachelor's degree from their home university, can be eligible for SF State's **College of Business** MBA program. ADMISSION REQUIREMENTS FOR PRE-MBA PROGRAM STUDENTS

- Complete at least 3 years of business program college/university coursework with a minimum 2.5 GPA
- Minimum TOEFL iBT 70 score, IELTS 6.5 or the equivalent
- Financial statement showing at least one academic year of tuition and living expenses is required (see below)
- No GMAT required

- Certified English translations must accompany official transcripts/diplomas/graduation certificates in the original language of issue from all schools
